### Transmission network extension in North West Surat Basin

## Blythdale, Fairview and Fairview South Substations Project

Powerlink Queensland invites you to comment on the Draft Environmental Impact Statement for the Blythdale, Fairview and Fairview South Substations Project,

Powerlink is responsible for the State's high voltage electricity transmission network, which transports electricity from power stations to the distribution networks (owned locally by Ergon Energy), and to major customers such as mines.

#### **About the Project**

Powerlink has been requested by Santos GLNG to establish direct connections into the high voltage transmission network to supply power to its future gas processing facilities in the area west of Wandoan

To meet this request, Powerlink is proposing to extend its network in the North West Surat via three projects:

- · Blythdale, Fairview and Fairview South Substations Project (the subject of this advertisement)
- Yuleba North to Blythdale Transmission Line Project
- Eurombah to Fairview Transmission Line Project.

The proposed network extension has been divided into three projects to ensure landowners and other stakeholders receive information and can provide comment on matters that are relevant

It is expected the proposed Blythdale, Fairview and Fairview South substations will be located on land currently owned by Santos GLNG in the areas north-east of Roma and west of Taroom. Powerlink is undertaking a project to assess the suitability of that land for this purpose.
