

## Tully-Ingham EPBC Compliance Assessment Report 2019

### Purpose

The purpose of this report is to address the status of compliance of each condition of the approval given to the Ingham to Tully 275/132kV Transmission Line Replacement, between Ingham and Tully, Far North Queensland, (2010/5346). The publication of this report is to fulfil the compliance requirements of Condition 3 of the of EPBC Act approval 2010/5346.

### Compliance Assessment

The action to which the approval relates is the decommissioning of the existing 132kV transmission line, and construction, operation and maintenance of a 275/132 kV dual voltage transmission line between Ingham and Tully. The construction phase of the action commenced April 2012 and was completed October 2013. The operation and maintenance phase of the action is ongoing.

As required by the conditions of approval, a Vegetation Management Plan, Mahogany Glider Management Plan and Mahogany Glider Offset Strategy have been developed and implementation is ongoing.

Powerlink commissioned qualified consultants North Queensland Land Management Services (NQLMS) and the Local NRM Group, Terrain, to provide monitoring and advice regarding aspects of the ongoing implementation of the Vegetation Management Plan, Mahogany Glider Management Plan and Mahogany Glider Offset Strategy. The monitoring and revegetation scopes of work were completed in June 2017.

Since last compliance report in 2017, only conditions 13 and 14 have been applicable to the current stage of the action (2010/5346).

All other conditions were either:

- only applicable during the construction of the line,
- never applicable,
- now completed, or
- relating only to the publication of the annual compliance report.

The table below sets out each condition, whether the condition has been applicable to date and the compliance status of each applicable condition of the approval.
