

## Update #4: Construction works at Ashgrove West Substation

December 2019

Dear resident,

This is an update from Powerlink Queensland on our Ashgrove West Substation replacement project. Construction works at the substation on Trinder Road at Ashgrove West started in May 2018 and are expected to continue **until October 2020**.

The project involves removing ageing substation equipment and installing new equipment within the existing site. All construction activities taking place are on Powerlink-owned land – no expansion of the existing site is required. **These activities will not result in any planned outages to your electricity supply.**

### Current works

Works are being delivered over several stages to ensure a safe and reliable electricity supply is maintained for the project's duration. Following the completion of Stage 1 activities in early 2019, Stage 2 works are well underway and will be progressively undertaken until February 2020 (weather dependent). This stage involves removing primary plant across three substation bays, installing new cabling, testing and commissioning works, and replacing oil separation equipment.

A range of machinery will continue to be used, including concrete trucks and pumps, and small excavators. Construction vehicles will also be on site as required.

There may also be increased noise and dust levels from the equipment being used, however as with all of our activities, care will be taken to minimise any disturbance. We are mindful of our neighbours and wherever possible have scheduled the more intensive Stage 2 construction works to occur during the December 2019/January 2020 school holidays. **Please note our crews will not be working over the Christmas and New Year period from Monday 23 December 2019, with works recommencing on Monday 6 January 2020.**

### Upcoming temporary road closure in January 2020

As part of our work to replace oil separation equipment, we need to receive an on-site delivery of large specialised equipment which will require a short closure of Trinder Road. It is expected this road closure will remain in place for up to one hour. We will provide you with more information on this activity closer to the time, to enable you to plan your movements and minimise any inconvenience. **We thank you in advance for your patience while this essential delivery takes place.**

### Future works

Our project team is still on-track to progressively deliver Stage 3 between April 2020 and October 2020. This will include removing primary plant across the three remaining substation bays, installing new cabling, final testing and commissioning works, and completing post-construction remediation works.



### **Minimising potential impacts**

To minimise any inconvenience to local residents, our working hours will continue to typically be between 6.30am and 6.30pm, Monday to Saturday (not including public holidays and our Christmas and New Year closure dates above). Powerlink does not expect any major work outside of these hours, however should the need arise we will inform you in advance.

At all times, we aim to conduct our activities with as little disruption as possible to the wider community. The project will continue to be undertaken in accordance with rigorous environmental management requirements, which clearly outline how potential impacts will be minimised and managed.

### **Traffic management**

As the substation is in a residential area, we are continuing to take all reasonable measures to minimise impacts to local traffic during our normal construction activities. Residents may notice increased traffic as vehicles access the site during peak construction periods. Construction vehicles will continue to primarily access the substation via Baileys Road and Trinder Road. Comprehensive traffic management plans will remain in place to help minimise any potential interruptions.
