- a new 101km double circuit 275 kV transmission line between Powerlink's existing Calvale Substation and Stanwell Substation;
- construction of two new 275 kV bays at Calvale and Stanwell Substations, within the existing substations;
- reconfiguration/movement of the existing Stanwell Bouldercombe feeders F848 and F849;
- movement of the existing 275 kV single circuit Calvale Stanwell feeder F855 landing span at Calvale Substation to provide room for the new line connection; and
- minor works on the existing 275 kV and 132 kV transmission lines near Calvale Substation to facilitate new crossings.
